Northwest Elementary School agrees to implement the following requirements as outlined by Section 1116:

 - All communications regarding meetings, programs, and other activities will be provided across multiple platforms and in all languages represented in the school population.
 - Meetings, programs, and other activities will be held during times that are convenient to parents and encourage the most participation when possible. Accommodations, where appropriate and feasible, will be provided to extend the outreach of parent participation to its furthest extent.
- If the school improvement plan under Section 1114(b) of the ESSA is not satisfactory to the families of participating children, submit any family comments on the plan when the school makes the plan available to the local educational agency.

- Be governed by the following statutory definition of parent and family engagement and will carry out programs, activities, and procedures in accordance with this definition: Parent and Family Engagement means the participation of families in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring:
 - o families play an integral role in assisting their child's learning;

 - families are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child; and
 - other activities are carried out, such as those described in Section 1116 of the ESSA.

 - School programs
 - Athletic events
 - Kindergarten and 8th grade graduations
 - Field trips
 - Ongoing communications between parents and staff
- School-Parent Compact will be a joint effort amongst all stakeholders by implementing all but not limited to:
 - meetings, questionnaires, and input gathered from families regarding changes, concerns, and suggestions for improvement or amendment to the current compact
- Involve families in the allocation of funds provided by the Title 1 Program by:
 Northwest will set forth a budget for Title 1 funding as provided by the district.
 - \circ All funding will be documented and reporting done annually to ensure funds are being spent in accordance with the assurances of the Title 1 Program. \circ One percent of funding will be reserved for family engagement and, if requested, can be

discussed with parent involvement committees.
